PUBLIC POLICY



The Texas 86th Legislature which began on January 3, 2019, will adjourn on May 27, 2019. Please be aware this article is being written two weeks before adjournment. It's crunch time. Many bills are dying or very close to it. What will become law in the remaining weeks is anybody's guess. I will follow the issues introduced in a previous article, namely, marijuana, criminal justice, school safety, property tax and school finance.

Marijuana

Can the Legislature begin to decriminalize marijuana? The House voted to reduce penalties for low-level possession in a proposal called House Bill 63, also known as B-to-C, which lowers the penalty from a Class B to a Class C misdemeanor, the same as a traffic ticket. It passed with two dozen Republicans joining the Democrats. But opposition from the presiding officer of the Senate, Lt. Governor Dan Patrick, remains a problem.

Can the Legislature broaden the use of medical marijuana? Medical marijuana usage in Texas is among the most restrictive in the nation. Both the Senate and the House have offered bills to expand use of medical marijuana. Both Republicans and Democrats have offered bills to do the same, but Lt. Governor Dan Patrick remains wary of any medical marijuana proposal that might become a means for expanding access to the drug. He will need a lot of convincing to change his mind.

Criminal Justice

The House moved to repeal the Driver Responsibility Program which many describe as a trap for low-income drivers which forces them into a cycle of debt or even jail time. It is difficult to repeal because it funds half of the state's emergency trauma care system. The lawmakers managed to unite both the hospitals and criminal justice advocates by shifting the funding to a broad base. Specifically, the measure would add a small fee to automobile insurance and increase state traffic fines. If the bill receives final House approval, it goes to the Senate.

School Safety

The Senate voted to approve a school safety bill which tries to prevent another Santa Fe High School tragedy, a tragedy which left 10 dead and 13 wounded a year ago. The Senate bill strengthens the ability of school employees, including substitute teachers, to respond to emergency situations by requiring that telephones or other electronic devices be placed in classrooms. Additionally, school districts must establish threat assessment teams to identify potentially dangerous students and determine how to intervene before violence occurs. Also included is the requirement to appoint school safety committees that meet regularly and provide the boards of trustees with updates. Lt Governor Dan Patrick signaled his approval of the Senate bill. It now goes to the House.

Property Tax Relief and School Finance

The lawmakers are trying to cap property tax increases which will directly or indirectly reduce revenue for Texas schools, while at the same time increasing revenue for K-12 education. Will voters love one tax cut so much they will ignore that another tax is paying for it?

The House approved a school finance bill that puts an extra \$9 billion into Texas schools. It includes pay raises, boosts funding by \$900 for each student, and drops the amount of money wealthy districts pay through the state's Robin Hood plan enacted in 1993. Both the Senate and the House are working on tax bills to cap property tax increases. The caps range between 2.5% - 3.5%.

But here's how we pay for it. The lawmakers raise sales taxes one percent to 9.25%. Oddly, the Republicans are in favor of increasing the sales tax and the Democrats are opposing the increase in sales tax.
