VOTER SUPPRESSION

Access to the ballot is key to democratic government. It allows the citizens to participate in shaping policy through direct referendums and choice of political representation. It is not only a right; it is a duty of every citizen to participate. Voter suppression is a means of depriving citizens of the right to voting access, i.e., disenfranchisement. A political party may choose to enact voter suppression measures to avoid the necessity of having to justify their agenda. It is a way of tilting the playing field to avoid competition in the marketplace of ideas and to avoid having to compromise. If you set the conditions of assured election wins, you never have to worry about appealing to more than a reliable, carefully chosen base. Voter suppression improves the ability of a particular party to retain power and to avoid accountability. It is a tactic favored by authoritarian leaders of every description. Voter suppression in any form has no place in a democracy.



Voter suppression takes many forms. They include banning drive through voting and 24-hour access to polls. Other such efforts include limiting early voting, closing polls at 7 p.m. regardless of voters remaining on line to cast a ballot, limiting access to mail-in ballot drop boxes, limiting polling places. There is disagreement about what is gained by demanding ID from people casting a ballot.

Specific to Texas, Both HB 6 and SB 7 impose a gag rule on election officials that prohibit them from "soliciting" votes by mail applications from Texans, backed up by criminal penalties. The language is so broad that they likely prohibit local officials from even mentioning the mere existence of voting by mail unless first prompted by a voter. These bills also undermine confidentiality for voters with disabilities and limited English proficiency with invasive questions that may require disclosure of private or medically confidential information. Also, these bills would give partisan poll watchers free rein in polling places. Texas poll watchers have a notorious track record of intimidating Black voters and voters of color, including in 2020. Allowing poll watchers to videotape voters inside the polls is an intimidating tactic.

Any election law that makes it more difficult to vote, and may disproportionately discourage participation by Black or Brown voters, should be seen as an attempt at voter suppression. Many people struggle with shift work, transportation, and child care. The Supreme Court in 2013 in Shelby V. Holder removed the ability of the Justice Department to enforce the Voting Rights Act of 1965 provision allowing oversight of states inclined toward discriminatory election practices. The rationale was that racism is a thing of the past.

A continuing problem with our elections in this country is low voter turnout. The election of 2020 had one of the best rates of voter participation that we have seen in many years. Moreover, there seems to be widespread agreement that the election of 2020 was a very free and fair election. There seems to be agreement that the 2020 election had no widespread fraud. Lawsuit after lawsuit has failed to demonstrate otherwise. No proof has ever been offered of widespread fraud.

Forty-three state legislatures have brought forth election legislation in the name of promoting integrity and confidence in the electoral process. There is a saying "If it ain't broke, don't fix it." As voters we need to understand what these proposed bills seek to fix and how passing them would address potential fraud.

Collection of documents

The end of the AAUW fiscal year is fast approaching, and it will be time to assemble the WHC Branch records/documents of our activities for the past year. Below are the guidelines for collecting them. Martha Ewell, Historian, is responsible for gathering these records for transfer to the U of H Library Carey Shuart Women's Research Collection. The fiscal year is always July 1 to June 30.

The U of H Library Archivist encourages us to collect <u>as many digital</u>, <u>paper</u>, <u>and loose materials as possible</u>. There is ample archival storage space to accommodate all materials that we collect that will contribute to our history and activities throughout the year.

Documents to collect and person responsible:

- Items such as pictures, old WHC video tapes and ephemera that individual members would like to submit to the archives.
- AAUW special interest groups (contents of emails or other publications when appropriate, photos, etc.)—
 the Leaders of each special interest/activity group
- Obituaries of AAUW WHC Branch members—the Corresponding Secretary
- Records still held in the personal collections of past leaders and members
- Records of Student Affiliate's activities

Timeline:

- Data collection takes place on an annual basis at the end of the calendar year on lune 30.
- All documents collected are submitted to the U of H Library Special Collections by the following August or September.
- The Branch Historian is responsible for collecting all documents both digital and paper.

Types of Documents:

- **Digital documents**—including primary digital documents. May be submitted on a zip/thumb drive or by email if appropriate.
- Paper documents—handouts, brochures, folders, any kind of paper document that supports the activity, etc. Paper documents are significant source of research material. Researchers like to "feel" the material and to view it in its original format. and find that these documents add to their understanding and appreciation of the materials by bringing it alive. Please make sure the documents are identified and dated.
- Memorabilia—any special items/artifacts that are pertinent to our activities but do not fall into the category of paper or digital documents.
- Audio-visual materials-Photos of meetings, events, special interest group activities—documented with date, activity, and the names of AAUW participants featured in the photo, power point presentations, videos. These may also be included in newsletters.
- Photos—it is essential to identify the members in the photos, the activity, the group, the date of activity
 and anything else which pertains to the photo. Without clear identification the photos have no meaning
 to the audience at large.


WISE Activity Group



Garden Divas



The Garden Divas will get Ideas for Native Pollinators in their May Meeting.

The Garden Divas will explore some ideas to replenish their frozen landscapes as well as learn how to create an environment to help save beneficial bees. We will 'ZOOM' with Jennifer Feeley, a Texas Master Gardener. She will enlighten the group with her expertise on native pollinators. Jennifer currently works at Wabash Feed & Garden, and has been doing organic gardening for over 30 years. She had one of the Organic Farms in the Coastal area. We will have an onsite 'ZOOM' at Wabash Feed Store to get up close and personal with suggested specimens. Wabash Feed & Garden has one of the most extensive selections of organic gardening supplies found in Houston.



Garden designs for pollinators do not need to be complicated, expensive or time-consuming. That's the beauty of going native! Pollinators have simple needs: they need a year-round supply of pesticide-free food and water, and bare ground or wood for nesting. Suggested plants include drought and heat tolerant plants that bloom and provide food most of the year, and are usually available locally.

Use pollinator-friendly landscape management practices. Avoid toxic pesticides, use organic alternatives instead which are safer for your family and pets. Limit pruning dead or dying branches with hollow stems; if possible, allow dead trees to stand or leave trunk stumps. Limit mowing grassy areas with low, dense cover. Limit artificial light sources, insects need natural light/dark cycles and protection from predators.


