Our speaker this month will be Dominique Royem who is the Music Director of the Fort Bend Symphony Orchestra. Dominique is an active guest conductor and has worked with ensembles such as the Ukrainian State Orchestra, Plevin Philharmonic, Galveston Symphony, Moores Opera Center, Sugarland Opera, HBU Opera Theatre, and the Houston Civic Orchestra. She was the Resident Conductor for Bayou City Concert Musicals, Music Director for Houston Grand Opera's Opera to Go! during the 12-13 and 13-14 seasons, and the Conducting Fellow for the Allentown Symphony Orchestra's 2012-2013 season. Dominique received a Doctorate in Orchestral Conducting from the University of Houston -Moores School of Music. Her dissertation, entitled "Generic Integration and Its Expressive Potential in the Music of Kurt Weill and Richard Rodgers," uses semiotic and genre theory to illuminate the similarities between opera and musical theatre in the 1940s and 1950s.

Dominique currently lectures at the Women's Institute of Houston. She will talk to us about her joy in bringing classical music to listeners everywhere. Check out her videos about Music History, Music Theory, and Pop Music on YouTube and various other social media platforms.

This month we thank **Nancy Gusler** for asking about the Randalls (and Kroger) Good Neighbor program. Once you have designated West Harris County AAUW on your Randalls or Kroger loyalty card, we receive valuable underwriting donations that help offset local fundraising expenses ~ at no additional cost to you!

- For Randalls, our number is still 1427. What's new is that you can now manage your designations through their website at www.randalls.com/yourstore/good-neighbor.html. (You will need to use your existing Randalls username and password or create new ones.)
- For Kroger, the code is still QY091, and now you can check your designations via www.kroger.com/account/communityrewards/ (with your Kroger username and password).

Randalls and Kroger suggests you use their smart phone apps in place of your physical loyalty cards. Also consider using the Stocard loyalty card app on your smart phone. You just load your loyalty cards into Stocard, and then you don't have to lug around all your retail cards, museum cards, etc. When you get to the store or museum, they just scan your phone screen, similar to the way airplane tickets and movie tickets work now. You can password protect the app, but it's not meant to secure personal details like bank or medical information.

The Equal Rights Amendment: Past, Present.....and Future?


Brief History of the Equal Rights Amendment

The Equal Rights Amendment (ERA) has a history dating back to 1923 when it was proposed by the National Woman's political party to provide for the legal equality of the sexes and prohibit discrimination on the basis of sex. Four decades later, the Amendment was introduced to Congress in the late 1960's. Feminists Betty Friedan and Gloria Steinem along with U.S. Representative, Bella Abzug of New York, provided the leadership. It won the necessary two-thirds vote in the House in October 1971 and was approved by the Senate in March 1972 and sent to the states for ratification. Hawaii was the first to ratify what would have been the 27th Amendment followed by some 30 other states within a year. By the fall of 1977, 35 states had ratified the ERA – three fewer than the 38 needed for adoption. The

ERA failed to achieve ratification by the necessary 38 states, or three-fourths of the total states, within the sevenyear deadline of March 22, 1979. The deadline was extended to June 30, 1982, but no additional states ratified the amendment within this deadline. Nevada ratified in 2017, Illinois in 2018 and Virginia in 2020. Because of the rejection of the ERA, gender equality, with the exception of the right to vote, is not fully protected by the U.S. Constitution.

What is the Current Status of This Beleaguered Amendment?

The amendment's supporters have taken the position that the amendment should be included in the Constitution since it was ratified by three-fourths of the states in accordance with Article V which gives the right for amendments to be proposed and become part of the Constitution. The U.S. Archivist, David Ferriero, declined to certify the ERA on the basis that the original deadline had expired and the last three states to ratify did not have standing to do so. In January 2020, Virginia, Illinois, and Nevada took legal action to order the Archivist to publish and certify the amendment and make the ERA part of the Constitution. The court ruled against the three states



recounting that the three ratifications had come after the deadlines and the Archivist was under no burden to publish and certify. The Justice Department, using AG Bill Barr's Office of Legal Counsel (OLC) Opinion, upheld this decision. In February 2022 Virginia asked to be removed from the case. Continuing the effort, Illinois and Nevada appealed seeking a court order to force the National Archivist to publish and certify the amendment. Dr. Colleen Shogan, new Archivist nominee, is on record saying she will adhere to the same OLC opinion as the former Archivist unless a court order deems otherwise. Illinois and Nevada had oral arguments scheduled for September 28, 2022 before the U.S. Court of Appeals for the District of Columbia Circuit, (Illinois v Ferriero). Immediately following the argument a press conference was held by ERA advocates calling for the Senate to vote on the time limit issue and calling for the Archivist to publish the ERA as the 28th Amendment of the U.S. Constitution.

What Might be the Future of the ERA?

Since 1982 proposed measures have been brought before Congress. One approach proposes bringing a new constitutional amendment regarding equal rights for men and women. If passed by both the House and the Senate it would be put to the states for ratification. Another approach relies on the fact that 35 state ratifications occurred prior to the first deadline. It further proposes that notwithstanding the deadline issues, three-fourths of



the states have now ratified and for all intents and purposes the amendment should become part of the Constitution as allowed by Article V. This approach known as the "three-state-strategy" has been passed by the House and is in the Senate where it awaits consideration. Democrats in Congress are attempting to remove the ratification deadline issue through a resolution that the House passed in 2021 and is now awaiting a vote in the Senate where it faces an uphill battle.

We can urge Congress to eliminate the deadline, helping to pave the way for the ERA's passage. Final passage of the ERA would protect laws like Title IX and the Equal Pay Act, which are not permanent protections, from being rescinded. Reproductive freedoms were recently stripped away by our conservative Supreme Court. Would the Equal Rights Amendment as part of the U.S. Constitution have prevented this loss? Arguably, a ratified ERA could have helped protect reproductive health care and, going forward, it could bolster efforts in the courts and legislatures regarding future reproductive rights as well as other rights at risk in a conservative legal and social environment.

As we know, rights are never absolute and must be continuously protected and fought for again if necessary. Measures are being taken to finally include the ERA as a permanent part of the U.S. Constitution. It is essential to continue to press for its ratification.

Culture Group

The Culture Group returns to San Felipe de Austin for new exhibits



Join us November 11 for a trip through early Texas history. From its founding by Stephen F. Austin in 1823 as the capital of his colony until it perished in flames in 1836 as the Mexican army of Santa Ana approached, San Felipe de Austin never grew much larger than roughly 600 residents. But during its 13-year existence near the Brazos River, Austin's

namesake settlement was the political capital of colonial Texas, second in commerce and population only to San Antonio. Many of Texas' most famous historical figures (Davey Crockett excluded) either visited or lived in San Felipe de Austin at one time or another in the ramp-up to the Texas Revolution. Villa de Austin's courthouse and government building replicate the site of colonial deliberations in 1832, 1833, and 1835.

San Felipe de Austin State Historic Site, operated by the Texas Historical Commission, tells the history of the old town site with a museum and visitor center which opened in 2018. In 2021, the site expanded its interpretation of the historic town with the opening of Villa de Austin, a collection of eight log and frame structures that replicate one of old San Felipe's busiest blocks. As part of the \$2 million project, the wooden structures were built by craftsmen at their shops in Virginia, Pennsylvania, and Fort Worth, and then shipped to San Felipe for reassembly.

Our guided tour will include both the museum and the town site. We will be outside for part of the tour so dress appropriately for the weather and walking. Lunch will be a box lunch of a delicious chicken salad croissant, pasta cup, cookie, and drink (tea or water) and it will be served in the Old Three Hundred Room. There is also a lovely gift shop. The cost of the tour and lunch is \$25.
