# **Public Policy**

# Will the Pink tax go away this Texas legislative session?

"Pink tax", "tampon tax", or "period tax" refer to the state sales taxes on feminine hygiene products like tampons, pads, liners, and other products essential to menstrual health. According to USA Facts twenty one states currently tax these products. Since 2016, 24 states have exempted menstrual products from state sales tax, while five states have no sales tax at all. Texas is among the states where consumers still pay tax on these products. Lawmakers are reluctant to make exceptions regardless of how



expensive these products have become, probably because of how large a revenue driver it is for states. The Texas Comptroller estimates that sales tax on feminine hygiene products generates \$28.6 million annually.

## Feminine hygiene products are classified as a luxury item as though they were optional, not essential.

Why will removing this tax help? "Period poverty is a common yet hidden and stigmatized public health issue in the United States and globally," according to Jhumka Gupta, an associate professor at George Mason University in a 2021 study. "It can reduce women's participation in school and the workplace."

According to the American Medical Women's Association, "period poverty refers to the inadequate access to menstrual hygiene tools and education, including but not limited to sanitary products, washing facilities, and waste management." Twenty Five million women live below the poverty line in the U.S. The cost for these essentials can be overwhelming. Some families have to choose between buying menstrual products and putting food on the table. If appropriate resources are not available, girls and women may miss school or work which can cause lower self-esteem and decrease earnings.

A number of bills have been filed that eliminate the tax on feminine hygiene products as well as essential baby items, adult diapers, and more. Senator Joan Huffman has made the effort one of her priorities. There are also companion bills filed in the house so both legislative bodies will be considering similar bills and make the effort more likely to become a law.

Here are the bills to support. Let your Texas legislators know you want them to vote affirmatively on these bills.

1) SB 379 Relating to sales and use tax exemptions for wound care dressings and certain feminine hygiene products. By Senators Huffman, Alvarado, Campbell, Eckhardt, Kolkhorst, LaMantia, Paxton, and Zaffirini

Companion bill: HB 1265 by Rep Button, Identical

2) SB 128 Relating to a sales and use tax exemption for certain feminine hygiene products By Sen Springer

Companion bills:HB 70 by Rep Howard, Very Similar; HB 510 by Rep Wu, Identical; HB 2320 by Rep C. Harris. Very Similar

3) HB 300 by Rep. D. Howard, which would exempt feminine hygiene products, diapers, baby wipes, baby bottles, maternity clothes and breast milk pumps from state sales and use taxes, has been voted out of committee and is waiting to be set for consideration on the House floor.

## Funds - Revisiting the National Legal Advocacy Fund (LAF)

At the exquisitely planned Thomsen-Baker-Telfer Scholarship Fund Luncheon in February, an intriguing question came up from the audience: "Whatever happened to the Legal Advocacy Fund?" Many of us remember a time when National set each branch's fundraising goals for the year. National also gave each branch a separate, percapita fundraising goal for the Legal Advocacy Fund, or LAF. The web page at <a href="www.aauw.org/resources/legal/laf/explains">www.aauw.org/resources/legal/laf/explains</a> the powerful reach that LAF still has:

Unfair pay, pregnancy discrimination, sexual harassment, sexual assault, and violations of Title IX of the Education Amendments of 1972 can affect both women and men. AAUW's Legal Advocacy Fund addresses these barriers by informing people of their rights and how to use the legal system to seek justice and change. LAF was created in 1981 by AAUW members and has provided millions of dollars to balance the scales of justice for people working toward gender equity through the legal system.



We support brave plaintiffs seeking legal redress for equal pay, Title IX, Title VII of the Civil Rights Act of 1964 and tenure denial violations. We allocate \$100,000 annually to help fund landmark cases, such as Wal-Mart v. Dukes and Cioca v. Rumsfeld, as well as cases with the potential to set future precedents like Rizo v. Fresno County Office of Education.

Did LAF merge into the Greatest Needs Fund, as someone at the

luncheon suggested? The short answer is no.

As it turns out, LAF is still alive and well and "well-funded into the future," to quote Angie Cooper, a senior manager at AAUW headquarters in Washington, D.C. Angie adds that today our decision makers in Washington have prioritized the Greatest Needs Fund. (This is why when you donate through <u>aauw.org</u> Greatest Needs appears first on the list of choices and LAF does not even appear on the list.)



won't want to miss it.



#### Garden Divas



The Garden Divas will visit the newly opened Land Bridge in Memorial Park on Tuesday, April 4.

Memorial Park has always been a haven for Houstonians, a place to escape the concrete jungle and reconnect with nature. Now the 1,500-acre urban park has added the Kinder Land Bridge and Cyvia and Melvyn Wolff Prairie that links the north and south halves of the park. But in the years since its construction and as various roadways were added, the park became divided into 27 pieces. The goal for the re-design was to create a land bridge that did more than serve a functional purpose of joining two spaces. This bridge would

accommodate spots for family-friendly activities, areas for passive recreation such as wildlife and prairie viewing, trails to Buffalo Bayou, and safe access and connectivity to different sections of the park.

Nearly 45 acres of native Gulf Coast prairie have been planted along the corridor, creating a more resilient ecology while providing a utilitarian benefit—the managing of stormwater to decrease the flooding notorious to this city. Memorial Park Conservancy's BioCycle Program composts trees lost in the 2011 drought, along with those removed within Memorial Park, into a rich soil that provides a healthier habitat for wildlife and absorbs greater amounts of stormwater. There are two mounds forming the land bridge. The land drapes itself over the tunnels—two in each direction that open in the middle for glimpses of the park from the road.

You can spot denizens of the park up or down because while the land bridge provides connectivity for wildlife *over* Memorial Drive, a stream corridor constructed through the prairie and a culvert provide connectivity *under* Memorial Drive. Nicknamed the "critter crossing," the culvert even provides shelving for animals, so they can scurry from one side of the park to the other and avoid the water below.

We are looking forward to our visit to this spectacular area of Memorial Park. The group will carpool from the parking lot at south of Memorial City off Barryknoll at 9:30 a.m. We should arrive at 10:00 a.m. at the Cullen Running Center, 7575 North Picnic Lane. Paid parking is available there and we will walk to the nearby bridge. Hat and sunscreen are highly suggested.
