Legislative Update: Bills on the Move



How is our lobbyist assisting our AAUW Texas Public Policy efforts? Our lobbyist provides the AAUW Texas Legislative Advisory Committee with a bill tract list and recommends action on the bills. The full list has over 200 bills on it based on the five priority issues: Women's Health and Reproductive Choice, Gun safety and Reduction in Gun Violence, Voting Rights and Election Law, Public Education, and Equal Pay.

The legislative session is holding many committee meetings and bills are being scheduled for votes. To become law a bill must pass both the Senate and the House and then be signed by the Governor.

What are some select bills that are on the move that the AAUW Texas Public Policy Advisory Committee is following? Listed here are bills with current stage in the process as of April 15, 2023, and our recommendation for AAUW member action.


