PUBLIC POLICY



Suggestions for Advocacy Action on

AAUW Texas Priority Topics and Bills of the 89th Legislative Session:

Women's Healthcare

Life of the Mother Act, SB 31 by Sen. Hughes & HB 44 by Rep. Geren Support

This bill would provide exceptions to otherwise prohibited abortions based on a physician's reasonable medical judgment. These bills would clarify when doctors are allowed to perform medically necessary abortions to save the life of the pregnant patient. These bills would revise the code to remove confusing language about medical emergencies that made doctors hesitant to provide lifesaving abortions. This carefully crafted legislation addresses one and only one issue—it would save women's lives and health, including future fertility, by clarifying that doctors and other health providers should practice evidence-based medicine, including terminating pregnancies that threaten the mother's life or health. **The bottom line is SB 31/HB 44 will save lives.** SB 31 was heard in Senate State Affairs on Thursday, March 27and was left pending in committee. HB 44 had a hearing in House Public Health April 7and left pending in committee. **Call the Chair and members of both committees and your representative to ask them to support these bills as they move forward.**

Minimum Standards of Care for Sexual Assault Survivors, HB 220 Rep. Ordaz & SB 1899 by Sen. Huffman Support

These bills would establish minimum standards of care for sexual assault survivors that improve the quality of support and treatment received by these individuals. It would require them to receive access to private spaces for consultation with medical providers and advocates, showers after examination, medication for sexually transmitted infections, and emergency contraceptives. HB 220 was heard in House Public Health Committee March 31st with Committee report sent to Calendars for a vote. **Call the Chair and members of the committee as well as your representative to ask them to support the bill as it moves forward.** SB 1899 is referred to Senate State Affairs but is not yet scheduled for a hearing.

Abortion Inducing Medications, Civil and Criminal Penalties for Facilitating, SB 2880 by Sen. Hughes and HB 5510 by Rep. Leach <u>Oppose</u>

This bill would prohibit the manufacture, possession, distribution, transport, and delivery of abortion-inducing drugs. It would criminalize providing information on obtaining these drugs or creating online platforms facilitating access, including criminalizing platforms that enable funding or distribution of abortion-related services. Allows civil lawsuits against violators, including damages for wrongful death or personal injury resulting from these drugs. It would criminalize payment for abortion services, destruction of evidence related to abortion, and extend the statute of limitations for prosecuting abortion-related offenses. **Significantly, SB 2880 could inhibit health care for patients who aren't even pregnant, including men. SB 2880** was heard in Senate State Affairs on Thursday, March 27th and left pending in committee. **HB 5510** has been referred to State Affairs Committee.

Prohibiting Local Government Support of Abortion Assistance, SB 33 by Sen. Campbell Oppose

This bill would prohibit local governments or other governmental entities from appropriating tax dollars to abortion assistance groups that indirectly support or facilitate out-of-state abortion services. It would expand the definition of "abortion assistance entities" to include any organization or individual that provides financial support, travel arrangements, childcare, or other logistical services that facilitate access to abortions. This would also empower the Office of the Attorney General, state residents, or individuals within a political subdivision to initiate legal action against any entity engaging in prohibited transactions, with provisions for recovering misused funds, court costs, and attorney's fees. **SB 33** was heard in Senate State Affairs April 7 with Committee report sent to Calendars for vote. **Call the Chair and members of the committee urge them to oppose SB 33**.

Public Education Related Issues

Vouchers/Education Savings Accounts, SB 2 by Sen. Creighton AAUW TX Opposed

The House passed SB 2 85 to 63 on April 16. SB 2 will likely go to conference committee as the version passed by the House is significantly different than the versions passed by the Senate.

Ten Commandments in the Classroom, SB 10 by Sen. King AAUW TX Opposes

SB 10 would require public schools to hang the ten commandments in a "conspicuous place" in the classroom. Text and frame size requirements are detailed in the bill. Classrooms and schools would be required to accept any private donation of a framed copy of the ten commandments. This bill passed in the Senate and was sent to the Public Education Committee.

Period of Prayer in Schools, SB 11 by Sen. Middleton AAUW TX Opposes

SB 11 would allow for a school board to elect to impose a period of prayer in public schools. A consent form would need to be signed and returned by each student. It is unclear where the prayer would take place, and who would administer it. The bill states that if every student consents to the period of prayer, that it will be allowed to occur over the loudspeaker of the public school. This bill passed on the Senate floor last week and sent to the House. <u>Call</u> your representative and let them know you oppose SB 10 and SB 11.

Public School Funding, HB 2 by Rep. Buckley AAUW TX Support

HB 2 is bill for the substantial public education funding for the upcoming biennium. It also included a variety of provisions for increasing school funding. AAUW TX supports any increase of funding for public schools. **HB 2 passed** in the house with a vote of 144 to 4 and will now go to the Senate for consideration. Call your Senator and <u>let</u> <u>him/her know you want the Senate to pass the increased funding contained in HB 2.</u>

Gun Safety and Reducing Gun Violence

Deregulating Short-Barrel Rifles, SB 1596 by Sen. Hagenbuch Oppose

SB 1596 would remove short-barrel rifles from a list of firearms that are prohibited from being purchased or possessed without being registered with the National Firearms Registration and Transfer Record maintained by the Bureau of Alcohol, Tobacco, Firearms and Explosives. Short-barrel rifles include but are not limited to sawed-off shotguns and other highly destructive firearms that have been used in several mass shooting events. Would legalize short-barrel firearms, a type of weapon regulated under federal law for its use in organized crime. This type of gun was used in the Santa Fe school shooting, which killed 10 and injured 13. These firearms are more easily concealable and maneuverable, enhancing their lethality. SB 1596 was passed by the Senate on April14. **Call your Representative to oppose SB 1596.**

Relating to the age at which a person not otherwise prohibited by state or federal law from possessing a firearm may carry a handgun or is eligible for a license to carry a handgun. HB 2470 Would allow 18–20-year-olds to carry handguns, licensed or unlicensed, despite data showing this age group is at higher risk for gun homicide and suicide. Left pending in Homeland Security, Public Safety Committee. **OPPOSE**

Relating to the possession of a firearm by persons convicted of certain felony offenses. HB 2771 It would remove serious felonies like stalking, aggravated assault, and terroristic threats from the list of crimes that prohibit gun possession in Texas. April 7 heard by committee and left pending in Homeland Security, Public Safety committee. **OPPOSE**

Relating to the carrying of concealed handguns by handgun license holders on the premises of a polling place on the day of an election or while early voting is in progress. HB 1794 Would allow guns in polling places, potentially discouraging civic participation and putting voters and election workers at risk. On April 14 heard and left pending in Homeland Security, Public Safety committee. **OPPOSE**

Relating to the locations where a handgun license holder may carry a handgun. HB 4201 Would allow more guns in sensitive places like schools by expanding where LTC holders can carry — and could be especially dangerous if paired with bills lowering the carry age to 18. April 14 heard and pending in Homeland Security, Public Safety committee. **OPPOSE**

Voting Rights: Free and Fair Elections

Proof of Citizenship to Vote, SB 16 by Sen. Hughes, et al. Oppose

This bill would require new registrants and existing registered voters who did not provide proof of citizenship when they registered to prove their citizenship before they could vote in state, local, and presidential elections (voting in any race other than those for U.S. Senate and House). Even if you are currently registered to vote, you would be required to show proof of citizenship documentation if you did not show it when you registered. Specifically, SB 16 would require individuals to provide documentary proof of citizenship, such as a birth certificate, passport, or naturalization papers, when registering to vote. This creates significant barriers, particularly for naturalized citizens, elderly voters, people with name changes and anyone who may not have immediate access to those documents. This bill mirrors the federal SAVE Act tightening voting laws. The burden is shifted to the voter to prove their eligibility, and it undermines the ability of VDVRs to register eligible citizens to vote. **SB 16 passed the Senate and been sent to the House. Call your representative to oppose.**

Ending Countywide Voting, SB 76 by Sen. Hall Oppose

SB 76 would eliminate the Countywide Polling Place Program in Texas. Many of our communities use county-wide polling locations to make it easier for people to vote near their place of work or in a manner that is convenient for them. This bill was left pending in committee. **Call the State Affairs committee to OPPOSE**

Prohibiting Rank Choice Voting, HB 817 by Rep. Cain & SB 310 by Sen. Hughes Oppose

This bill would prohibit rank choice voting in Texas elections. Rank choice voting and instant runoffs are designed to ensure the winner of an election is the candidate with a majority of support. SB 310 passed in the Senate and referred to the House Elections Committee **Call your representative_to oppose SB 310.** HB 817 was passed by the House and is on the House calendar for vote. <u>Call your representative</u> to oppose HB 817 and SB 310.

Prohibits a public employee from distributing voter registration application forms, HB 1489 by Rep. Oliverson and SB 511 By Sen. Bettencourt <u>Oppose</u>

This bill would prohibit any officer or any employee of the state of Texas (for example public school teachers) from distributing a voter registration form to a person who did not request it. HB 1489 was heard in the House Elections Committee last week and left pending. **Call the committee and ask them to oppose HB 1489. SB 511 to be voted on in the Senate.**

Withholding County Registrar Funds, HB 1478 by Rep. Cain Oppose

This bill would permit the Texas Secretary of State to withhold funds from a county voter registrar who fails to perform voter registration duties, including those related to any challenges to voter registration. HB 1478 was voted favorably out of committee last week. <u>Call your representative</u> to oppose HB 1478.

Increasing Criminality for Election Offenses, HB 1661 by Rep. Vasut & SB 507 by Sen. Bettencourt Oppose

This bill would increase criminality for election offenses by increasing the punishment for multiple election offenses (elevating from a misdemeanor to a felony) and creating two new misdemeanor election offenses related to election supplies, e.g., failing to provide sufficient ballots to a precinct, and closing polling places. **SB 507 was voted** favorably out of committee. <u>Call your senator</u> to oppose SB 507. HB 1661 was voted favorably out of committee. <u>Call your senator</u> to oppose SB 507. HB 1661 was voted favorably out of committee.

Micromanagement of Ballot Language, HB 1783 by Rep. Paul & SB 506 by Sen. Hall

This bill would make changes to ballot measure language provisions for home-rule cities and expand the state's authority over their wording, including requiring that the language not mislead voters. It also gives the Secretary of State authority to review municipal ballot measures and to write the measure if the municipality fails to meet the Secretary of State's assessment of clarity. **These bills have been heard and <u>left pending in the Elections</u> Committee/State Affairs committees to oppose.**

Expansion of Rights for Poll Watchers and Candidates, SB 2309 by Sen. Hughes & HB 4989 by Rep. Dorazio **OPPOSE**

This bill would expand poll watchers' rights to include observing the opening of polling locations, inspecting ballot boxes, and observing ballot box transfers to other locations. It also requires the currently required video surveillance system to expand to include hallways, doorways, and offices while also expanding the time frame of the video surveillance system to the entire election period. Further, it requires a "large analog clock" to be visible on the live stream. It allows candidates to be present for more post-election processes currently not open to candidates or parties. SB 2309 was heard and left pending in committee. HB 4989 has been referred to the Elections Committee/State Affairs committee but has not been heard. **Call committee members to oppose.**

Voter Deputy Registrar Appointment Renewal, HB 1297 by Rep. Vo Support

This bill would require the registrar to provide notice of the expiration of a volunteer deputy voter registrar's (VDR) term, along with a renewal application and information about any relevant changes in law. VDRs who submit renewal applications will be immediately appointed to a new term with no gap in appointment. **It has been heard and left pending in committee.**

Garden Divas



The Divas are 'traveling' in May! We will be visiting the **Wildseed Farms** and spending two nights in Fredericksburg. The farm has more than 1,000 cultivated acres in Texas and over 200 acres of wildflower fields at its Texas Hill Country headquarters outside of Fredericksburg. The fields surrounding the property are mostly in bloom March through October. The farm offers the highest quality non-GMO wildflower seeds, including hard-to-find native grasses. They are the world's largest producer of Texas Bluebonnets and carry a wide variety of fruit, vegetable, and culinary herb seeds perfect for large gardens or patios. The

Nursery at Wildseed Farms is one of the largest plant nurseries in Central Texas. They offer a large selection of in season plants and gardening products as well as garden décor, and pottery. The butterfly gardens are surrounded by a half mile of walking trails, nestled in their production crops. The walking trail allows you to stroll at your leisure and see some of our fields in different stages of growth. In addition to visiting the farm, we will have an option to visit an Outdoor Art Museum. The Coming King Foundation (TCKF) was formed on April 6, 2004 as an independent 501c3, non-profit organization. Free TCKF "Covenant Certified" art gardens are being established across the USA and world. Several renowned sculptors have already donated their monumental sculptures. There are fabulous opportunities for shopping and enjoying the beautiful 'hill country'. We will be staying Monday and Tuesday nights, (May 5 & 6) and will be visiting the **Wildseed Farms** on Tuesday. Established as a depot next to Houston's Grand Central Station in 1934, the present-day structure was designed by the same architectural firm that built the Astrodome. The new building became the Houston headquarters of the USPS in 1961. In 1984. the Post



Office was named after Barbara Jordan, the first African American woman elected to the Texas Senate. The HUGE structure was redeveloped in 2015 as the POST, one of the jewels on the downtown scene, a hub for culture, food and recreation. Noteworthy is the rooftop Skylawn and garden, a state-of-the-art Music Hall and an International Food Hall with 25+ vendors. You will enjoy the food and the view! We will meet at our usual Memorial City Mall parking lot (12125 Barryknoll) at 10:00 a.m. and carpool to the POST.
